1. Tikapur Municipality has allocated funds towards the cost of **Construction of Kailashsewar Shiva Mandir Building Works**, Tikapur Municipality Ward No.1, Tikapur, Kailali and intends to apply part of the funds to cover eligible payments under the Contract for **Construction of Kailashsewar Shiva Mandir Building Works**, Tikapur Municipality Ward No.1, Tikapur, Kailali (Contract No: TMO/NCB/02/BUILD./2082/083). Bidding is open to all eligible bidders as per Section V of Bidding Document.
2. Tikapur Municipality, Office of Municipal Executive, Tikapur, Kailali invites electronic bids from eligible bidders for the **Construction of Kailashsewar Shiva Mandir Building Works**, Tikapur Municipality Ward No.1, Tikapur, Kailali under National Competitive Bidding-Single Stage Two Envelope Bidding Procedures. Only eligible bidders with the following key qualifications should participate in this bidding:
Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: **NRs. 2.80 Crore**
Minimum Work experience of similar size and nature : **One Project of Value NRs. 0.93 Crore without VAT**
3. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.

 8. The bids will be opened in the presence of Bidders' representatives who choose to attend at **22th, Janaury, 2026, 14:00 hours** at the office of Tikapur Municipality, Kailali, Nepal. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of **NRs. 7,02,000.0** which shall be valid for 30 days beyond the validity period of the bid.
